4. FIRST AID MEASURES

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Notes to physician: Treat symptomatically.

Clinical findings: The smooth muscle relaxant effect of nitrate salts may lead to headache, dizziness and marked hypotension. Cyanosis is clinically detectable when approximately 15% of the haemoglobin in the blood has been converted to methaemaglobin.

- At approximately 30-40% of methaemaglobin, headache, dizziness, weakness and shortness of breath may occur.
- At approximately 60% of methaemaglobin, stupor, convulsions, coma and respiratory paralysis may occur. The blood is a chocolate brown colour.
- At higher levels death may result.

Treatment is for exposure to nitrates: Give 100% oxygen. In cases of ingestion; use gastric lavage. Dermal cases are treated with continued washing until all ammonium salts are removed. With cases of visible symptoms and those when the methaemoglobin level is greater than 40%, a clinician administers methylene blue.

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

LARGE SPILLS

Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops or waterways has occurred advise emergency services or State Department of Agriculture.
